**Action Matters**

**Approval of Makeup of Executive Director Screening Committee (Vote Required)**

Jeanne Sullivan presented a retirement letter to the board on November 20, 2025. She will be retiring effective June 30, 2026, after serving as the Executive Director of BICO for six years. Dr. Amy Berdos, Chair of the BICO Board, gave an overview of the search process and the tentative timeline. The proposed makeup of the Executive Director Screening Committee is: 2-4 Board Members, 2-4 Operating Committee Members (Special Ed Admin), 2-4 BICO Central Office, 1 BICO Program Director, 2-4 BICO Program Staff (Teacher, Para, Counselor, BCBA, RBT, etc...). Motion by Dr. McIntyre, seconded by Ms. Kidwell, to approve the makeup of the screening committee. The roll call vote to approve was unanimous. Dr. Antonucci was not present to vote.

**Approval of BOD Representation on Executive Director Search Committee (Vote Required)**
